FERNANDO CASAL BÉRTOA Associate Professor, School of Politicss and Int. Relations, University of Nottingham (UK)

**Fernando Casal Bértoa** is an Associate Professor in the School of Politics and International Relations at the University of Nottingham (United Kingdom). He is member of the OSCE/ODIHR "Core Group of Political Party Experts". He is also codirector of REPRESENT: Research Centre for the Study of Parties and Democracy. His work has been published in Journal of Politics, European Journal of Political Research, Sociological Methods and Research, Perspectives on Politics, Electoral Studies, West European Politics, Party Politics, Democratization, European Political Science Review, among others. He was awarded the 2017 Gordon Smith and Vincent Wright Memorial Prize, the 2017 AECPA Prize for the Best Article and the 2018 Vice-Chancellor Medal of the University of Nottingham for "exceptional achievements". His latest book, titled Party System Closure: Party Alliances, Government Alternatives and Democracy in Europe (Oxford University Press., 2021) was awarded the AECPA (Spanish Political Science Association) Best Book Price and an Honourable Mention for the ECPR Stein Rokkan Prize.

**Andreas Michael Klein** has more than 20 years of working experience for the Konrad-Adenauer-Stiftung (KAS) since February 2000 as director of the newly established country office in Skopje/Macedonia (2000-04), as desk officer at the Department for International Cooperation in Berlin/Germany (2004-06) as well as director of the KAS' offices in Dusseldorf/Germany (2006/07), Riga/Latvia (2007-12), Hamburg/Germany (2012-16) and Santiago de Chile (2016-22). Since April 2022, Andreas is the Director of KAS' Regional Programme Political Dialogue Asia. He has studied Political Science, Modern History and Spanish at the University of Bonn/Germany (1993-1999), of which he holds a MA degree in Political Science, and Intercultural Communication at the University of Jyväskylä/Finland.

**Moritz Fink** is fulfilling his 2 year Director-in-Training programme with KAS Singapore in the Political Dialogue Asia office. Before this, Moritz was responsible for the area of Global Health in the HQ of the foundation as a consultant in the main department Analysis & Consulting since February 2022. He already brings substantial points of contact with the Asian region. Moritz was part of the "EU-ASEAN Think Tank Dialogue Series" supervised by KAS Singapore as well as a fellow under the "EU-ASEAN Young Leaders". CHUN-YI LEE Associate Professor School of Politics and Int. Relations & Director, Taiwan Research Hub UNUK



*PHILIP LIU HSIAO-PONG* Professor at the Graduate Institute of Development Studies National Chengchi University Taiwan

Chun-Yi Lee is Associate Professor at school of Politics and International Relations, University of Nottingham. She is also the director of Taiwan Studies Program at Nottingham. Chun-Yi's first book was published by Routledge in 2011: Taiwanese Business or Chinese Security Asset. The book is under Leiden Series in Modern East Asia History and Politics. Chun-Yi applied from the Economic and Social Research Council (ESRC) with Prof. Andreas Bieler on the project, 'Globalisation, national transformation and workers' rights: An analysis of Chinese labour within the global economy' in 2010. This project successfully received the funding from the ESRC and started to operate from October 2011 till September 2014. In viewing the Chinese labour facing the challenge of industrial upgrading, Chun-yi applied a research project funded by Chiang-Ching-kuo (CCK) Foundation in Taiwan in relation to 'Chinese Investment in Taiwan: Challenge or Opportunity for Taiwan's Industrial Development'. This project has finished in December 2016. Currently, Chun-yi is working on a public policy research project, to compare Taiwan and UK government's strategies to counter Covid-19. Meanwhile Chun-yi is working her second monograph on the topic of 'China's New Normal: The Impact of China's Rise on the Global Political Economy'.

**Philip Liu Hsiao-pong** is a distinguished professor at the Graduate Institute of Development Studies and holds the esteemed position of director of the International Master's Programme in Asia-Pacific Studies at National Chengchi University in Taiwan. With his wealth of experience and expertise, Professor Liu plays a crucial role in shaping the academic landscape and nurturing intellectual growth within the university community. His dedication to both research and education underscores his commitment to excellence and innovation in the field of Asian-Pacific studies.




CHRISTIAN SCHAFFERER Associate Professor, Department of International Trade, Overseas Chinese University, Taiwan

**Christian Schafferer** is Associate Professor at the Department of International Trade, Overseas Chinese University, Taiwan. He has served as President of the Asian Political and International Studies Association (APISA), President of the Austrian Association of East Asian Studies, and founding Editor-in-Chief of the Journal of Contemporary Eastern Asia (JCEA). His research interests embrace political and economic studies with special reference to East Asian societies; current research projects deal with the impact of social media on electoral campaigns and democratization in Asia.



**ROGER DO** CEO & Founder, AutoPolitic



After returning to Asia, he formed AutoPolitic which has so far been part of over 92 campaigns, while winning 75% of the time, operating at both strategic and tactical levels. He is currently working with Ukrainian volunteers through their embassies to combat Russian disinformation and influence across ASEAN.

**Chean Chung, Lee (MP)** is a State Assemblyman of Semambu, Pahang, Malaysia. He was elected National Central Committee of People's Justice Party (KEADILAN) before being appointed as National Communication Director. He was also the National Treasurer General (2018-2022) and Youth Wing's National Information Chief (2014-2018) of the party. Chean Chung holds a Master in Public Administration from Lee Kuan Yew School of Public Policy, National University of Singapore (NUS). Earlier, he graduated from Malaysia University of Science and Technology (MUST) in MSc. Transportation & Logistics and Bach. (Hons) Electronics Engineering (majoring in computer) from MMU.

In 2019, Chean Chung co-founded Centre of Regional Strategic Studies (CROSS), a progressive think-tank focusing on regional cooperation, economic development, poverty alleviation and sustainability issues. In 2022, he founded #ScamVictimSupport, a mutual-help group that empowers and assists victims of scamming and financial frauds.

Sanghoon Kim-Leffingwell Assistant Director and a senior lecturer at John Hopkins University

At Johns Hopkins, **Sanghoon Kim-Leffingwel** is the Assistant Director and a senior lecturer for the MS in Data Analytics and Policy program.

His research focuses on authoritarian nostalgia and related political behavior in post-authoritarian democracies, especially East Asian countries. His dissertation investigated why individual voters feel nostalgic for an authoritarian past and vote for political parties that are linked to the past. His research has been supported by various sources, including a Taiwan Fellowship from the Ministry of Foreign Affairs of Taiwan and a Doctoral Fellowship from the Chiang Ching-Kuo Foundation for International Scholarly Exchange.



**JULIO C. TEEHANKEE** Professor of Political Science and International Studies at De La Salle University, Philippines

Julio C. Teehankee is an educator, researcher, and political consultant with a wide experience in electoral and political party related activities since 1984. He has continuously worked to bridge theory and practice in academic and other professional endeavors. He has written and published extensively on elections and political parties in the Philippines and Asia. He has participated in several election campaigns in the Philippines and has served as adviser to presidential candidates. Currently, he is a Professor of Political Science and International Studies at De La Salle University where he served as Chair of the Political Science Department (1994-2007); Chair of the International Studies Department (2008-2013); and Dean of the College of Liberal Arts (2013-2017).



Herbert Kitschelt George V. Allen Distinguished Professor of International Relations at Duke University

**Herbert Kitschelt** is a Professor of Political Science, specializes in comparative political parties and elections in established and new democracies, comparative public policy/political economy, and 20th century social theory. In the 1980s and 1990s, he authored three books in German about comparative industrial and technology policy and related social movements, with condensed English journal articles summarizing some of the findings.



**YVES TIBERGHIEN** Professor, Department of Political Science, University of British Columbia

**Yves Tiberghien** is a Professor of Political Science and Konwakai Chair in Japanese Research at the University of British Columbia (UBC) in Vancouver, Canada. He is also Director Emeritus of the Institute of Asian Research, and Director of the Center for Japanese Research.

Yves is Distinguished Fellow at the Asia-Pacific Foundation of Canada and a Senior Fellow at the University of Alberta's China Institute. He is an International Steering Committee Member at Pacific Trade and Development Conference (PAFTAD). In November 2017, he was made a Chevalier de l'ordre national du mérite by the French President.



*Larry Diamond* Senior Fellow at the Hoover Institution and Professor of Sociology and of Political Science

**Larry Diamond** is a senior fellow at the Hoover Institution and the Mosbacher Senior Fellow in Global Democracy at the Freeman Spogli Institute for International Studies (FSI) at Stanford University. He also chairs the Hoover Institution Project on Taiwan in the Indo-Pacific Region and is the principal investigator of the Global Digital Policy Incubator, part of Stanford's Cyber Policy Center. For more than six years, he directed FSI's Center on Democracy, Development, and the Rule of Law, where he now leads its Program on Arab Reform and Democracy. During 2017–18, he cochaired, with Orville Schell, a working group formed of researchers from Hoover and from the Asia Society Center on US-China Relations, culminating in the report China's Influence and American Interests: Promoting Constructing Vigilance (published by the Hoover Institution Press in 2019). He is the founding coeditor of the Journal of Democracy and also serves as senior consultant at the International Forum for Democratic Studies of the National Endowment for Democracy.



**MARCIN WALECKI** Senior Resident Country Director for the National Democratic Institute (NDI) in Ukraine

Marcin Walecki has over 25 years of democratic governance, elections, rule of law, anti-corruption, academic and management experience working in more than 50 countries around the world. Former Head of Democratization Department of the Office for Democratic Institutions and Human Rights, one of the world's principal regional human rights bodies and the first Executive Director of the European Partnership for Democracy (www.epd.eu). Consulted on, and conducted Council of Europe, USAID, EU, DFID, IDEA, OECD, UNODC and UNDEF democratization programmes. He has written for numerous publications on democratisation, political corruption, elections, women political participation and political parties. Polish citizen holds a DPhil in Politics from St. Antony's College at Oxford University and a Master's in Law (Hons, Class I) from the Department of Law and Administration at the University of Warsaw.



**BANN SENG TAN** and International Relations at Ashoka University, India

Bann Seng Tan is an Assistant Professor of Political Science and International Relations at Ashoka University, India. Before Ashoka, he was an Assistant Professor at Bogazici University, Turkey and has taught at the College of William and Mary, at Queens College (CUNY) and at Hunter College (CUNY). He received his PhD in Political Science from the Graduate Center at the City University New York (CUNY). He was also a senior research scholar at New York University and is part of the AidData Research Consortium at William and Mary. He does research on the causes and effects of democratization. His dissertation was on the effects Assistant Professor of Political Science of democratization on interstate conflict behavior (the democratic peace). His first book, International Aid and Democracy Promotion: Liberalization at the Margins, articulates a way to promote political reforms despite the pushback by recipients and the relative indifference of Western donors.



**CHANG LING HUANG** Professor for Political Science National Taiwan University

Chang-Ling Huang is Professor of Political Science at the National Taiwan University. She is currently working on a comparative study of quota politics in East Asia and serves as Director of the Global Asia Research Center at the NTU. She has works that have appeared in various Chinese and English academic journals and recently has authored chapters on gender politics in two handbooks. Huang received her Ph.D. from the University of Chicago. She is a recipient of the Outstanding Teaching Award and Outstanding Social Service Award from the National Taiwan University. Besides teaching and research, Huang has been involved in Taiwan's feminist movement. She was a board member and president of the Awakening Foundation, the earliest established feminist organization in post-war Taiwan, and a member of various government gender commissions.



CHARLES MCLEAN Japan Foundation Postdoctoral Associate, Incoming Assistant Professor of Political Science Yale University

**Charles McClean** is a incoming Assistant Professor of Political Science at Yale University. He brings a wealth of expertise in comparative politics, with a specialized focus on the politics of age and Japan. His groundbreaking research, published in esteemed journals such as the British Journal of Political Science, Comparative Political Studies, and Political Behavior, has earned him recognition within the academic community and beyond. Charles's work has been featured in prominent news outlets including the Asahi Shimbun, Nikkei Shimbun, National Public Radio, The Wall Street Journal, and The Washington Post.



**Yen-jong Lee** Director of DPP's Gender Equality Department, Attorney-at-law

**Yen-jong Lee** is the Director of the Democratic Progressive Party's (DPP) Gender Equality Department. As a seasoned attorney-at-law, she brings a wealth of legal expertise and advocacy experience. With a strong commitment to advancing gender equality and social justice, she plays a pivotal role in shaping policies and initiatives within the DPP to promote gender equity and empower marginalized communities



**CHEN I-HSIN** Former spokesperson for the Kuomintang

**Chen I-Hsin** (former legislator, MP, KMT) served as the spokesperson for the Kuomintang, but left the position to return to SOAS and pursue doctoral studies in economics. By 2014, Chen had resumed his spokesperson duties, while also working for the Kuomintang's Culture and Communication Committee. In February 2015, he was named a spokesman for the Office of the President, serving until 2016, when Ma Ying-jeou concluded his second term as president.

JULIA ROKNIFARD Assistant Professor Faculty of Social Sciences University of Nottingham, Malaysia

**Julia Roknifard** joined the University of Nottingham Malaysia in September 2019. Prior to that, she has been the Director for Foreign Policy at EMIR research, a Kuala Lumpur based think-tank. She has served as a Research Fellow at the National Research University "Higher School of Economics" in 2010-2019 and is currently a Consultant with the PIR Center, Moscow-based think-tank specialized on international security and nuclear non-proliferation.

Julia is specialized on Iranian and Middle Eastern Studies, matters surrounding Iran's nuclear program, Iran's domestic politics and foreign policy. Her research interests lie with international security, including its non-traditional aspects, interweaving of religion and politics, evolution of Islamism, and counterterrorism. She also teaches security courses (International Security - UG; Human Security and Contemporary Security Challenges - PGT) and Politics and International Relations of the Middle East (UG)



**DR. DON S. LEE** Assistant Professor, Graduate School of Governance at Sungkyunkwan University, South Korea

**Don S. Lee is** an assistant professor in the Graduate School of Governance at Sungkyunkwan University. He received a Ph.D. in political science from the University of California, San Diego. His research interests lie at the intersection of the political economy of institutions and public administration/policy. His research has been published or is forthcoming in Comparative Political Studies, Governance, Oxford Handbook, Policy & Politics, Public Administration Review, and among others.

**Chia-hung Tsai** is research fellow of the Election Study Center and professor at the Graduate Institute of East Asian Studies at National Chengchi University. YEN-PIN SU Professor Department of Political Science National Chengchi University, Taiwan

Asian Political & International Studies Association - In November 2001, 30 academics from research institutes, think tanks, and universities introduced the idea of launching an Asian-based academic organization dedicated to the advancement of political and international studies. It was the general consensus of the meeting that Asian scholars had been marginalized from the decision-making processes of the Western-based associations of a similar nature. Asian schools of thought had been stifled as a consequence of the American hegemony in the social sciences, and that the state of Asian studies in general was underdeveloped. In the light of these concerns, APISA was established and held its founding congress in Singapore in 2003.

Patterned after academic institutions in North America and Western Europe, the organization seeks to promote theoretically informed comparative scholarships, based on the Asian experience in the fields of conflict and peace, democracy and governance, development, and area studies.

The **OSCE Academy** in Bishkek promotes regional cooperation, conflict prevention and good governance in Central Asia through offering postgraduate education, professional training and intellectual exchange. The Academy pursues its mission through particular set of activities, including: Providing expert training and education in human rights, media development, conflict prevention, management, resolution, post-conflict rehabilitation, and in economics, governance and development; Conducting demand-driven and practice-oriented research on relevant Central Asian topics aiming at local, national and regional securitybuilding; Supporting the exchange of information and scientific cooperation among Central Asian academic institutions and their international partner organizations and Establishing and developing a regional network of professionals and researchers, see http://www.osceacademy.net/en/
