## Welcome

Welcome to this seven-day intensive Summer School organised by the OSCE Office for Democratic Institutions and Human Rights (ODIHR) and the European Consortium for Political Research (ECPR), under the auspices of the ECPR Standing Group on Central East European Politics and the support of the ECPR Standing Group on Political Parties. This Summer School, organized with the collaboration of the Cardinal Stefan Wyszyński University (Warsaw) and the Research Centre for the Study of Parties and Democracy: REPRESENT (University of Nottingham) brings together an international team of 6 academics and 6 practitioners to train and instruct a group of 11 MA/PhD researchers and 11 practitioners and civil society leaders in the field of political parties and democracy.

The main aims of the Summer School include to:

- to provide instruction and discussion on a wider range of analytical perspectives in the study of political parties, party systems, elections and democracy;
- to develop a multinational forum for both junior scholars and practitioners to critically discuss their research projects and the development of the subfield;
- to assist PhD researchers to develop their dissertation projects at the cutting edge of the field, contributing to innovation in conceptualisation, measurement, analysis and theory;
- to prepare PhD researchers for the requirements and criteria of international academic publishing, and to encourage them to submit their work to academic journals;
- to help practitioners to understand the main academic findings regarding party politics and democracy promotion;
- to build on the most recent developments of political party development and democracy promotion presented at most recent interdisciplinary International Conference in Birmingham (26-27 April) and Brussels (18-20 June);
- to stimulate international collaboration in the field of parties, party systems, elections and democracy and to encourage PhD researchers and practitioners to take part in such collaboration.

## Logistic information

### *Arrival at the airport*

Warsaw Chopin Airport (<http://www.lotnisko-chopina.pl/en/passenger/>) is the main airport of Poland, located about 8 kilometres from the city centre.

Ibis Stare Miasto hotel is located in the vicinity of the OSCE ODIHR office.

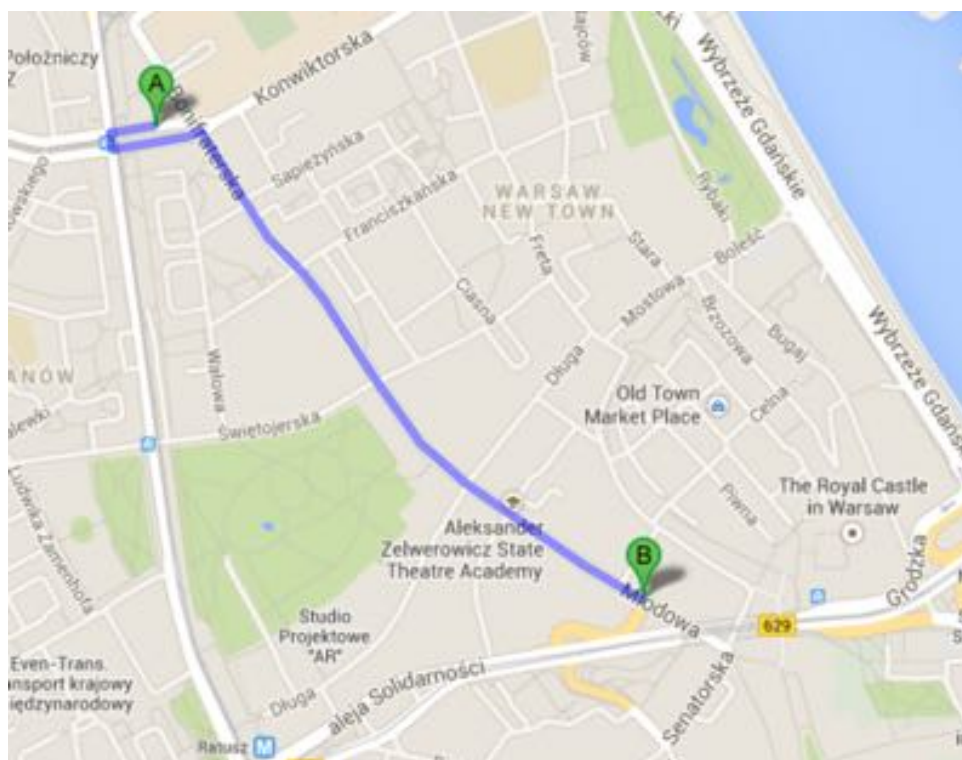


### *Venue*

## Biographies

### *Directors*



Fernando Casal Bértoa is an [Assistant Professor](#) in the School of Politics and International Relations at the University of Nottingham (United Kingdom). He is member of the [OSCE/ODIHR “Core Group of Political Party Experts”](#). He is also co-director of [REPRESENT: Research Centre for the Study of Parties and Democracy](#). His work has been published in *Journal of Politics*, *European Journal of Political Research*, *Sociological Methods and Research*, *Electoral Studies*, *West European Politics*, *Party Politics*, *Democratization*, among others. He was awarded the 2017 Gordon Smith and Vincent Wright Memorial Prize, the 2017 AECPA Prize for the Best Article and the 2018 Vice-Chancellor Medal of the University of Nottingham for “exceptional achievements”.



Katarzyna Grzybowska-Walecka is an Assistant Professor and the Head of MA studies on Politics in Cyberspace at the Cardinal Stefan Wyszyński University (UKSW) in Warsaw. She holds a PhD in Social and Political Science from the European University Institute (EUI) in Florence and she was also a Chevening Scholar at St. Antony's College, Oxford. Co-founder and co-leader of the business academic project/partnership called Political Radar, which monitored and analysed the only activity of political parties and political movements in Poland before and after the 2015 elections. She is also co-editor of Polish academic journal "Politologia".

Before becoming an academic, she was elected as one of the youngest city councillors in Warsaw, and worker for the European Parliament in Brussels as well as the United Nations Headquarters in New York.

### *Speakers*



Lenka Bušíková is an Assistant Professor in the School of Politics and Global Studies at Arizona State University. Her research focuses on party politics, voting behavior, clientelism, and state capacity, with special reference to Eastern Europe. She is the recipient of the 2015 APSA Best Article Prize for her article "Revenge of the Radical Right", published in the *Comparative Political Studies*; as well as the 2017 APSA Best Paper Prize for her paper, co-authored with Cristina Corduneanu-Huci "Patronage, Trust and State Capacity: the Historical Trajectories of Clientelism".



Andriy Meleshevyich is the President of the National University of Kyiv-Mohyla Academy, a leading institution of higher education in Ukraine, and a Professor of Law and Politics. He received a Master's in Law from Kyiv University and holds a Ph.D. from the Maxwell School of Citizenship and Public Affairs at Syracuse University. He was awarded a visiting fellowship at Stanford University in 2010, and has also served as a visiting professor at Groningen University (Netherlands), Heidelberg University (Germany), Dusseldorf University (Germany), Syracuse University (United States), and Yerevan University (Armenia). He is widely published in the fields of institution-building in the post-Soviet transitional countries, political consequences of electoral laws and executive-legislative arrangements, political parties,

comparative constitutionalism, European human rights law, and philosophy of law. Professor Meleshevyich is a member of the Ukrainian Constitutional Commission and the National Council of Ukraine on Anticorruption Policy.



Zuzana Papazoski is the Resident Director for NDI in Poland and legislative consultant for Central and Eastern Europe (CEE) programs. She manages the implementation of several NDI projects in Poland and the CEE region, including overseeing the regional Central Europe Democracy Initiative (CEDI). A long-time NDI staff member, she also oversees NDI's Western Balkans Legislative Strengthening program, a multi-year effort to strengthen the law-making and

oversight functions of the Western Balkans' parliaments, promoting transparency and





accountability in national policymaking. She earned her master's in law from Comenius University in Bratislava.



Richard Lappin is the Deputy Head of the Election Department at the OSCE's Office for Democratic Institutions and Human Rights (ODIHR). Richard is responsible for the overall administration and operational planning to assist the 57 OSCE participating States in implementing election and democracy-related standards through field-based election observation missions and technical assistance activities. He has worked extensively on the development of methodology and research, including the publication of the ODIHR Handbook on the Follow-up of Electoral Recommendations, the ODIHR Handbook for the Observation of Campaign Finance, the ODIHR Review of Electoral Legislation and Practice in the OSCE, and the ODIHR and Venice Commission Joint Guidelines on the Misuse of Administrative Resources during Electoral Processes. He has worked as a gender focal point for six years.

Prior to joining ODIHR, Richard worked on elections and democracy assistance projects with the UN, EU and Carter Center and has administered elections in the United Kingdom. Richard holds a PhD on post-conflict democracy assistance from the University of Leuven and a LLM in international human rights law from the University of Oxford.



Marcin Walecki possesses over 15 years of democracy assistance and governance experience working in more than 30 countries around the world. He also presents regularly at international conferences, seminars, and has written for numerous publications on democratization, political corruption, political financing, elections, political parties, gender equality and good governance. A Polish citizen, Walecki holds a doctorate of philosophy in politics from St. Antony's College at Oxford University and a master's in Law from the Department of Law and Administration at the University of Warsaw.



He is a former Max Weber Fellow at the European University Institute in Florence, Italy and a board member of the International Political Science Association Research Committee on Political Finance and Political Corruption.



Tiina Kukkamäe-Bah is the Chief of Democratic Governance and Gender Unit of the OSCE Office for Democratic Institutions and Human Rights (ODIHR) based in Warsaw, Poland. Before joining ODIHR in March 2016, she worked as the Executive Director of Political Parties of Finland for Democracy, Demo Finland, a collaborative organization of Finnish political parties in the field of democracy support. She has worked with governments, political parties, and civil society for the past 15 years, focusing on supporting democratic and inclusive governance, political participation of women and youth as well as civil society development across Asia and Africa alongside the OSCE region. She has also held various board positions, for example with the European Partnership for Democracy (EPD) and The Finnish NGDO Platform to the European Union, Kehys. Ms Kukkamäe-Bah has a Master's degree in Sociology from the University of Helsinki.



Anete Erdmane, Associate Democratic Governance Officer at the OSCE Office for Democratic Institutions and Human Rights (ODIHR). Her work focuses on promoting the political participation of persons with disabilities. Anete has been working with the OSCE since 2013, including on various human rights and democratic governance issues in Kosovo and Kyrgyzstan. Prior to that, she worked as the legal advisor at the office of the Ombudsman of the Republic of Latvia and NGO “Resource Centre for People with Mental Disability “Zelda” where she provided legal aid to people with mental health and intellectual disabilities and advocated for legal and policy reforms in Latvia. From 2012 until 2017 she served as a Management and Executive Board member of the EU Agency of Fundamental Rights. Anete holds a law degree from the University of Latvia and a Master’s Degree in Human Rights and Democratization (E.MA) from the European Inter-University Centre for Human Rights and Democratization and University of Leuven.

#### *Guest experts*



Wojciech Gagat is Assistant Professor at the Institute of Political Science of the University of Warsaw and Part-Time Professor at the Alcide de Gasperi Research Centre at the European University Institute in Florence. He holds an MA in Political Sciences and MA in Law (from





the University of Warsaw), PhD in Political and Social Sciences (from the European University Institute in Florence), habilitation in Political Sciences from the University of Warsaw. Currently he conducts a study on the role of the Group of the European People's Party in the development of the European integration process and of the directly elected European Parliament and leads a research project entitled *The Multi-Level Testing of Theories of Party Adaptation - the Polish Case* (funded by the Polish National Science Centre).



Ben Stanley is Assistant Professor in the Centre for the Study of Democracy at the SWPS University of Social Sciences and Humanities. He received a PhD in Government from the University of Essex and has worked at the Institute for Public Affairs in Bratislava, the Cardinal Stefan Wyszyński University in Warsaw, and the University of Sussex in Brighton, United Kingdom (as Marie Curie Intra-European Fellow). His primary area of research interest is the politics of populism in Central and Eastern Europe, incorporating analysis of party ideological appeals and voter behaviour. His current research activities include an experimental analysis of the links between conspiracy theory mentality and populism in Poland, measurement of populist attitudes in Central and Eastern Europe, and a monograph on Polish populism.



Ajla van Heel, Adviser on Gender Issues of the OSCE Office for Democratic Institutions and Human Rights (ODIHR) The work of Ajla van Heel Merdanović focuses on advancing women's political participation. While at ODIHR, she contributed to the development of the following publications: Gender Equality in Elected Office: A Six-Step Action Plan, Handbook for National Human Rights Institutions on Women's Rights and Gender Equality, Comparative Study of Structures for Women MPs in the OSCE Region, Handbook on Promoting Women's Participation in Political Parties, and Compendium of Good Practices for Advancing Women's Political Participation in the OSCE Region. Prior to joining the OSCE, she worked with the International Organisation for Migration (IOM) and United Nations Development Programme (UNDP), mainly on combating trafficking in women and girls in the Western Balkans. Ms. van Heel holds a bachelor degree in international affairs from Princeton University and a master's degree in human rights from University of Bologna. Her efforts to promote peace and advance women's rights were recognized through awards received from the British Royal Family, Rotary International, and Zonta International.



Jacopo Leone (Italy/United Kingdom), Democratic Governance Officer, OSCE Office for Democratic Institutions and Human Rights (ODIHR). Jacopo has been working as a political analyst for over eight years in the field of democracy assistance and governance, with a strong focus on parliamentary strengthening, political party assistance, anti-corruption, public integrity, and civil society development. Currently working as a Democratic Governance Officer at the OSCE Office for Democratic Institutions and Human Rights (ODIHR), he provides analyses of political developments and delivers assistance to OSCE participating States on democratic governance issues, with particular attention on strengthening integrity in parliaments and political party systems, promoting inclusive political institutions and youth and women's political participation. 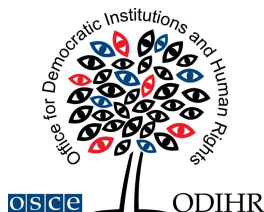

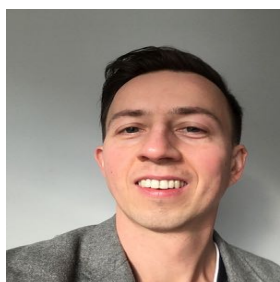
