## Welcome

Welcome to this seven-day and a half intensive Summer School organised by the OSCE Office for Democratic Institutions and Human Rights (ODIHR) and the European Consortium for Political Research (ECPR), under the auspices of the ECPR Standing Group on Central East European Politics and the support of the ECPR Standing Group on Political Parties. This Summer School, organized with the collaboration of the Cardinal Stefan Wyszyński University in Warsaw (UKSW) and the Research Centre for the Study of Parties and Democracy: REPRESENT (University of Nottingham) brings together an international team of 12 academics and 10 practitioners to train and instruct a group of 15 MA/PhD researchers and practitioners and civil society leaders in the field of political parties and democracy.

### The main aims of the Summer School include:

- To provide instruction and discussion on a wider range of analytical perspectives in the study of political parties, party systems, elections and democracy;
- To develop a multinational forum for both junior scholars and practitioners to critically discuss their research projects and the development of the subfield;
- To assist PhD researchers to develop their dissertation projects at the cutting edge of the field, contributing to innovation in conceptualisation, measurement, analysis and theory;
- To prepare PhD researchers for the requirements and criteria of international academic publishing, and to encourage them to submit their work to academic journals;
- To help practitioners to understand the main academic findings regarding party politics and democracy promotion;
- To build on the most recent developments of political party development and democracy promotion presented at most recent interdisciplinary International Conference in Birmingham (26-27 April 2018) and Brussels (18-20 June 2018);
- To stimulate international collaboration in the field of parties, party systems, elections and democracy and to encourage PhD researchers and practitioners to take part in such collaboration.

# Biographies

### **Directors**



Fernando Casal Bértoa is an Associate Professor in the School of Politics and International Relations at the University of Nottingham (United Kingdom). He is member of the OSCE/ODIHR "Core Group of Political Party Experts". He is also co-director of REPRESENT: Research Centre for the Study of Parties and Democracy. His work has been published in *Journal of Politics, European Journal of Political Research, Sociological Methods and Research, Electoral Studies, West European Politics, Party Politics, Democratization, European Political Science Review*, among others. He was awarded the 2017 Gordon Smith and Vincent Wright Memorial Prize, the 2017 AECPA Prize for the Best Article and the 2018 Vice-Chancellor Medal of the University of Nottingham for "exceptional achievements". His last book is titled *Party System Closure: Party Alliances, Government Alternatives and Democracy in Europe* (Oxford University Press, 2021).



Katarzyna Grzybowska-Walecka is an Assistant Professor and the Head of MA studies on Politics in Cyberspace at the Cardinal Stefan Wyszyński University (UKSW) in Warsaw. She holds a PhD in Social and Political Science from the European University Institute (EUI) in Florence. She was also a Chevening Scholar at St. Antony's College, University of Oxford. Co-founder and co-leader of the business academic project/partnership Political Radar, which monitored and analyzed activity of political parties and political movements in Poland. She is also co-editor of Polish academic journal "Politologia". Prior to turning to academia, she was elected as one of the youngest city councillor in Warsaw (three times in row), worked for the Office for Promotion of Parliamentary Democracy at the European Parliament and for the United Nations' Department of Peacekeeping Operations in New York. Currently, Katarzyna is a Jean Monett Fellow at the Robert Schuman Center for Advanced Studies at the European University Institute in Florence.

Nina Chanturia is an Associate Programme Officer in the Democratic Governance and Gender Unit of the OSCE Office for Democratic Institutions and Human Rights (ODIHR). Nina possesses experience in the area of democratization, EU integration, policy analysis, women's political empowerment and election observation. Nina has worked for OSCE/ODIHR EOMs since 2013. She chaired IRI's Women's Democracy Network in Georgia and acted as a project manager for "Women's Leadership Schools", a joint program of WDN and UNDEF. Nina has also served at the Embassy of Georgia to the Netherlands. She led various youth initiatives across the Europe and was a board member of AEGEE-Europe's youth unemployment program. **Augusta Featherston** serves as the Youth Focal Point in the OSCE Office of Democratic Institutions and Human Rights (ODIHR). In this role Augusta develops and oversees ODIHR's youth political participation portfolio, implementing activities designed to assist OSCE participating States meet their commitments in supporting the active participation of young people in promoting democracy, human rights, and fundamental freedoms. Prior to ODIHR, Augusta served as the technical lead on youth engagement at the International Foundation for Electoral Systems (IFES) advising on youth-specific program design, and other global youth initiatives. She also has extensive experience working with various youth-serving organizations supporting young people in underserved communities in the United States though innovative literacy, technology, and leadership development programs. Augusta holds an M.A. in international development from the Josef Korbel School of International Studies at the University of Denver.



Jolanta Cichocka. Senior Administrative Assistant, OSCE Office for Democratic Institutions and Human Rights (ODIHR). Since 2005 Ms. Jolanta Cichocka has been providing administrative and project support to the Democratic Governance and Gender Unit in ODIHR. Before ODIHR, in years 1992-2004 worked for the International Finance Corporation, Regional Office for Central Europe (World Bank Group) as the Office Manager and Program Assistant. She holds a Master's Degree from Institute of Applied Linguistics of the Warsaw University.

### **Speakers**



Thijs Berman has been Director of the Netherlands Institute for Multiparty Democracy since February 2019. After graduating in psychology, he became a journalist in 1987 and worked as a correspondent for the Dutch media in Paris and Moscow. He was also a radio and TV presenter for Dutch public broadcaster Interkerkelijke Omroep Nederland (IKON). Between 2004 and 2014 he was a Member of the European Parliament for the Dutch Labour Party (PvdA) and party leader in the European elections in 2009. He then worked in the Central African Republic (2015-16) organizing elections. Between 2016 and 2019 he worked at the OSCE in Vienna as an Advisor to the Representative for Media Freedom.



**Lenka Buštíková** is an Associate Professor in the School of Politics and Global Studies at Arizona State University. Her research focuses on party politics, voting behavior, clientelism, and state capacity, with special reference to Eastern Europe. She is the recipient of the 2015 APSA Best Article Prize for her article "Revenge of the Radical Right", published in the Comparative Political Studies; as well as the 2017 APSA Best Paper Prize for her paper, co-authored with Cristina Corduneanu-Huci "Patronage, Trust and State Capacity: the Historical Trajectories of Clientelism".



Russell J. Dalton is Research Professor at the Center for the Study of Democracy at the University of California Irvine. He studies the role of citizens in the democratic process, involving the topics of political culture, electoral politics, and political representation. Dalton's most recent books include: The Good Citizen, Political Realignment – Economics, Culture and Electoral Change, The Participation Gap, and The Civic Culture Transformed. He has received a Fulbright Professorship at the University of Mannheim, a Barbra Streisand Center fellowship, a German Marshall Research Fellowship and a POSCO Fellowship at the East/West Center.



Liz David-Barrett is Professor of Governance and Integrity at the University of Sussex and Director of the Centre for the Study of Corruption. Her research focuses on corruption risks at the interface of business and government, in particular in international business and public procurement. Her research on private-sector collective action to combat corruption identifies key conditions for success in changing international norms, while current work focuses on anti-corruption leadership in systemically corrupt contexts. As the Director of the Centre for the Study of Corruption, Liz leads the Centre's activities in research, teaching and policy impact.

She engages widely with anti-corruption practitioners globally, especially in sub-Saharan Africa, the Caribbean and Europe, and advises the UK Foreign Commonwealth and Development Office and the G20 on their international anti-corruption work. She is also a member of the RUSI Taskforce on a Transatlantic Response to Illicit Finance (TARIF). Before becoming an academic, Liz worked as a journalist in the Balkans for The Economist and Financial Times. She has a DPhil, MSc and MA from Oxford and an MA from the University of London.



Susan Dodsworth is currently a Lecturer at the University of Queensland's School of Political Science and International Relations. Prior to this, she worked as a Research Fellow at the University of Birmingham's International Development Department. The focal point of Susan's research is the relationship between democratization and development. She is particularly interested in the role of political institutions (especially parliaments) in both of these processes, and the extent to which external or international actors affect democratization and development – both intentionally and unintentionally. Her current research focusses on two topics related to these themes: the impact of women in African parliaments, and the practice of election observation in Africa and beyond. In 2019, Susan was part of a research team that won both the UK ESRC's Celebrating Impact Prize for Outstanding International Impact and the Market Research Society President's Medal.



Konstantine Vardzelashvili. Since 2018, is the Chief of the Legislative Support Unit (LSU) of the OSCE Office for Democratic Institutions and Human Rights (ODIHR), which assists participating States in evaluating compliance of draft or existing legislation with the OSCE Human Dimension commitments and international standards. In providing such support, LSU produces legal opinions, reviews law-making system of pS and draws on legislative guidelines in specific areas, such as freedom of assembly and political party legislation. Previously, he was a substitute member of the Venice Commission of the Council of Europe (2007 - 2015) and a Vice Chair and member of the United Nations Human Rights Committee (2012-2016). Furthermore, he served as the Vice-President of the Constitutional Court of Georgia (2006-2016) and as Deputy Minister of Justice of Georgia (2004-2006).



Radivoje Grujić is a Democratic Governance Officer with OSCE/ODIHR, previously serving as Election Adviser for seven years with the same Office, being desk officer for dozen countries in OSCE region. Radivoje is citizen of Serbia. Since late 1990's he has been engaged in various types of civic activism at home and on international level, through election observation, democracy and civil society development – working in election and democratic governance assistance programs with different agencies such as the Council of Europe, IFES, NDI, Transparency International and as an independent consultant, in Moldova, Georgia, Jordan,

Ukraine, Serbia and other countries. His work includes advocacy on many public policy issues and think-tank development. In election observation, Radivoje was part of citizen observer groups in Serbia, and also participated in many international election observation missions throughout the OSCE region. Prior to joining OSCE/ODIHR, Radivoje served as Country Representative of IFES in Serbia, supporting political finance oversight with state institutions and civil society. Radivoje holds a university degree in Law from Belgrade University.



**Tim Haughton** is Reader (Senior Associate Professor) in European Politics at the University of Birmingham, where he served as Head of the Department of Political Science and International Studies (2016-18) and the Director of the Centre for Russian, European and Eurasian Studies (2012-14). Dr Haughton was a Visiting Fellow at Harvard University's Center for European Studies and an Austrian Marshall Plan Foundation Fellow at Johns Hopkins University's School of Advanced International Studies. Dr Haughton has good links with the policymaking community, having briefed inter alia five British Ambassadors to Slovakia before they took up their posts. Tim's research interests encompass electoral and party politics, electoral campaigning, the role of the past in the politics of the present, the domestic politics of Slovakia, Slovenia and the Czech Republic and Brexit. He is the co-author with Kevin Deegan-Krause of The New Party Challenge: Changing Cycles of Party Birth and Death in Central Europe and Beyond (Oxford University Press, 2020), the editor of *Party Politics in Central and Eastern Europe*: Does EU Membership Matter? (Routledge, 2011) and served as the co-editor with Nathaniel Copsey of the Journal of Common Market Studies' Annual Review of the European Union for nine years (2008-16).



**Krzysztof Izdebski**, board member and policy director of ePanstwo Foundation (EPF) and board member of Consul Democracy Foundation. Marshall Memorial Fellow. He is a lawyer specialized in access to public information and re-use of public sector information. He has wide expertise in relations between public administration and citizens.
